In 1986, he joined the Doral Tuscany Hotel in New York and two years later, he was transferred to Miami as Resident Manager, and subsequently promoted General Manager of the Doral Saturnia International Spa Resort. During his tenure with the resort, Mr. Nissenbaum's leadership led to the resort becoming the only US spa resort at the time to earn the distinction of AAA Five-Diamond status.

In 1997, Mr. Nissenbaum returned to New York and joined The Plaza Hotel as Resident Manager. Mr. Nissenbaum is joining The Peninsula Beverly Hills from Omni Hotels, where he is Regional Vice President of Operations responsible for nine hotels. In 2006, he was concurrently appointed as the Corporate International Liaison to the Global Hotel Alliance, a collaborative partnership with several international, privately-held hotel groups.

Mr. Nissenbaum is currently a member of the Board of Directors with The New York Hotel Association and sits on the Advisory Board of the ITM Hospitality Fund (USA).
